Trustee Wear made a motion for a In Car Video System, for the new police squad that is on order, from Motorola for \$5,865.00. Trustee Washkowiak seconded the motion. All six Trustees voted yea. Motion carried.

Trustee Wear made a motion for Chief Bernardi to apply for possible ARPA Funds through Vermilion County. Trustee Sheets seconded the motion. All six Trustees voted yea. Motion carried.
